## SBA Deadline to Apply for Working Capital Loans in Kentucky is June 22

**ATLANTA** – The U.S. Small Business Administration is reminding businesses in **Kentucky** that working capital loans are still available to small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and private nonprofit organizations affected by the severe storms, torrential rains, tornadoes, severe wind, hail and flooding on July 3-9, 2016.

“Businesses that suffered economic losses as a result of the disaster and want to apply for low-interest loans from the SBA are urged to do so before the **June 22** deadline,” said Frank Skaggs, director of SBA Field Operations Center East.

Low-interest disaster loans are available in the following counties: Calloway, Christian, Graves, Livingston, Logan, Lyon, Marshall, McCracken, Muhlenberg, Todd and Trigg in **Kentucky**; Montgomery and Robertson in **Tennessee**.

Working capital disaster loans up to \$2 million are available at 4 percent for small businesses, and 2.625 percent for private nonprofit organizations with terms up to 30 years. The loans are intended to pay fixed debts, payroll, accounts payable, and other expenses that could have been paid had the disaster not occurred. To be considered for this assistance, eligible entities need to apply by the deadline.

Survivors may apply online using the Electronic Loan Application (ELA) via SBA’s secure website at <https://disasterloan.sba.gov/ela>.

The deadline to return economic injury applications is **June 22, 2017**.
