Appendix A: Exploratory Call Script (for incidents declared on or after September 7, 2020)

This script includes the Applicant Impact Survey (AIS) questions that the Program Delivery Manager (PDMG) uses to conduct the Exploratory Call (EC). The PDMG reviews the AIS (and completes it if the Applicant has not yet completed it). If the Applicant has completed it (or portions of it), the PDMG will see the completed fields in the EC module. The information provided in italics are tips for the PDMG and does not read these to the Applicant. The PDMG explains every question and asks the Applicant to answer to the best of its ability from the choices provided. There are no wrong answers and the information provided during the EC does not affect the Applicant's funding. The system does not allow unanswered questions. To add notes in the EC module, use the "Details/Notes" button, then "Add Note."
